BUSINESS MEETING

Called to order at 1:03 pm by 1st Vice President Lynda Vargas.

- No adjustments to agenda.
- President's Report (by 1st Vice President Lynda Vargas)
- New Board (sworn in at AFSS Conference in April) assumed roles in July, and there have been several changes since that time. Recording Secretary and Treasurer positions are currently vacant. Sallie Ross-Filgo has stepped into the Historical Committee chair and Molly Collins has taken on the Meeting Host Coordinator position. Committee vacancies are Education and Training Chairperson and Communications Chairperson.
- CalChiefs Report (by 1st Vice President Lynda Vargas)
 - CalChiefs Conference was held the end of September in Sacramento and was very successful. Executive Director Eric Dutton and Heather expressed gratitude to the AFSS North Board who assisted with registration and other duties during the conference.
 - Chief Dutton officially retired from his position as Executive Director effective October 1. Retired Cosumnes Fire Chief Tracey Hansen has been named to this position.
 - Fire Chief Mark Hartwig completed his term as President and has turned the reins over to Fire Chief Jeff Meston (South Lake Tahoe Fire). Chief Edmond Rodriguez (City of Alameda Fire Chief) is President-Elect.
