# B. President's Report - President Joyce Engler

# A. Education & Training

#### C. Membership

Donna Heymans reported that she has begun the new fiscal years membership drive. Currently there are 180 members, 6 of which are new (90 are paid, 90 are yet unpaid). She has mailed brochures to 600 non-member agencies and will send out invoices to current/past members. She will call members who don't respond and ask if they plan on renewing. If not renewed the member will be move to the non-member list. If they respond and say payment is forthcoming, currently they remain on the active list. Last year members remained active with benefits for a year. This year non-paying members will be moved to non-member status. Members are more likely to renew and retain membership if information on website is current, updated, and relevant. Non-paid members currently continue to get emails, however this will not happen this year. Shawn Crawford suggested that Education and Training Committee continue emailing links. Jodi distributed budget with some changes – tax filing added prep

Joyce Engler stated that she wanted to paint a clearer picture of revenue and expenses so she developed a sample budget packet detailing the breakdown of each budgeted item identifying what built the budgeted amount. The budget should be balanced and reflect a reserve account. In addition, the membership had decided to expend the remaining bank balance funds as incentives for the membership. This is noted as well.

- D. FOLSOM Bev Fuchs reported that Folsom has applied for a grant for a live burn mobile fire training trailer (to be a shared resource with Sac Metro FD, Sac City FD, and Cosumnes CSD).
