5. Section Chief Reports:

- A. Fire Chief Paul Benson, Chino Valley Independent Fire District, was unable to attend due to a previous commitment.
- B. Fire Chief Dan Haverty, Folsom Fire Department, was unable to attend due to a previous commitment. The next board and conference call will be held on May 7; a CFCA Financial Summit will be held May 20-22 by invitation only.

6. SOG - Requests for AFSS Assistance from other CFCA Sections:

A draft edition of this SOG was presented. AFSS North suggested an initial request form be included with the SOG. 7. Review Proposed Bylaws Revisions

A report from the Bylaws Committee (South) was distributed. A suggestion was made to have Coordinators from both Bylaws Committees at the Joint Executive Board Meetings so they can participate and get information first hand.

<u>Section 1.4 Organization and Section 6.1:</u> Clean up changes only. Motion by Becky Timmers to clean up Section 1.4 by removing the word "in-active". Second by Sue Beville. M/S/C

Section 3.8 Vacancies was discussed. No changes will be made to this section.

Section 3.9.2 Elections was discussed. The second paragraph was changed to read:

Ballots, when required, shall be distributed to each qualified member one month prior to the quarterly meeting at which the slate of officers was presented and must be returned to the Nominating Committee no later than five (5) days after receipt.

Motion by Becky Timmers to change Section 3.9.2 as stated (see above). Second by Christine Flores. M/S/C

<u>Article V - 5.2 Quorum - General Membership/Special Meetings</u>. Discussion to change wording to:

A quorum for each General membership meeting shall consist of no less than four (4) Executive Board members and the General Membership of that Division in attendance. Motion by Christine Flores, second by Joyce Engler. M/S/C

<u>Section 6.3 - Eligibility to Vote:</u> Discussion. Most voting is done electronically. Suggestion was made to announce at the beginning of the meeting: if you know you are in arrears, please abstain from voting. No change necessary.

The Bylaws Committee noted if changes can be handled through SOGs that is the appropriate way to make them.

Information regarding the 2010 Conference was distributed. The Conference will be held April 13-16, 2010 at the La Quinta Resort in La Quinta.

9. AFSS Brochure

Christine Flores, 1st Vice President, South, reported on the new AFSS brochure. New logos were introduced by the South. Suggested changes will be made to the proposed logo which will then be e-mailed to the E-Boards for an approval vote. The new AFSS logo is copyrighted, the only changes allowed are sizing up or down.
