

### CITY OF SACRAMENTO'S DRIVER TRAINING WAIVER AND RELEASE OF LIABILITY FOR STUDENTS

The City of Sacramento ("City") and County of Sacramento operate the Sacramento Regional Driver Training Facility ("SRDTF") at 3905 Alert Road, Mather, California 95655. This facility provides specialized drivers training for public emergency personnel (police, fire, ambulance) as well as training for commercial drivers. The City is making driver training available to members of the public, including students. Participation in SRDTF driver training is completely voluntary.

I understand, acknowledge and agree that in consideration of being allowed to participate in SRDTF training:

- I waive and release any and all claims, lawsuits or other actions for any injury or damage
  that I may incur arising out of or in any way connected with my participation in SRDTF
  training, and I release and forever discharge the City and County of Sacramento, their
  officers, agents and employees from any liability for any and all such claims, lawsuits or
  other actions.
- 2. I waive and release any and all rights or claims for indemnification and defense for tort liability, against the City and County of Sacramento, their officers, agents and employees, that I may have arising out of or in any way connected with my participation in SRDTF training.
- 3. In executing this document, I waive and release any and all rights or claims that I may have under the provisions of California Civil Code Section 1542 as now worded and as hereafter amended, which section presently reads as follows:
  - "A general release does not extend to claims which the creditor does not know or suspect to exist in his or her favor at the time of executing the release, which if known by him or her must have materially affected his or her settlement with the debtor."
- 4. I acknowledge that I have voluntarily applied to participate in SRDTF training. My SRDTF training is taking place from \_\_\_\_\_ (month/date/year) to \_\_\_\_\_ (month/date/year).
- 5. I am aware of the dangers of driver training, including, but not limited to, vehicle accidents, all of which may result in injuries and damages to persons and property. I assume the risk for any and all injuries or damage that I may incur arising out of or in any way connected with my participation in SRDTF training.
- 6. I assume responsibility for any damage or injury that I may cause to any property or persons, negligently or intentionally, arising out of or in any way connected with my participation in SRDTF training, and I agree to defend, indemnify and hold harmless the City and County of Sacramento, their officers, agents and employees with respect to any liability, claims, actions, lawsuits, expenses or costs (collectively, "liabilities") arising on

account of or related in any way to any such damage or injury, except liabilities alleged to have occurred in full, or in part, as a result of active negligence by the City or County, their officers, agents or employees.

- 7. This document shall survive the completion and end of my participation in SRDTF training.
- 8. Severability. If any portion of this waiver and release of liability or the application thereof to any person or circumstance shall be held invalid or unenforceable, the remainder of this waiver and release of liability shall not be affected thereby and shall be enforced to the greatest extent permitted by law.
- 9. I have carefully read this document and fully understand its contents. I am aware that this is a waiver and release of liability and a contract between me and the City of Sacramento, or a contract between me, my parent or legal guardian, if I am a minor. I sign it of my own free will.
