- A. **Call to Order**: President Moreno called the meeting to order at 9:15 a.m.
- B. Additions to the Agenda: Nothing additional was added to the agenda.
- C. <u>Review of April 21, 2008 Executive Board Meeting Minutes</u>: Upon a motion by Becky Timmers, seconded by Karen McCoy and unanimously carried, the minutes of the April 21, 2008 Executive Board Meeting was approved as amended.
- D. <u>Review of April 21, 2008 Joint Executive Board Meeting Minutes</u>: Upon a motion by Becky Timmers, seconded by Christine Flores and unanimously carried, the minutes of the April 21, 2008 Joint Executive Board Meeting was approved as amended.
- E. Review of June 10, 2008 Quarterly Meeting Minutes: Upon a motion by Karen McCoy, seconded by Becky Timmers and unanimously carried, the minutes of the June 10, 2008 Quarterly Meeting was approved as amended.

- F. Review of Agenda for September 9, 2008 Quarterly Meeting: The Board reviewed and approved the draft agenda for the September 9, 2008 quarterly meeting. The meeting will be hosted by Corona Fire Department.
- G. <u>Charitable Contributions</u>: 2nd Vice President Becky Timmers reported on behalf of Treasurer Lisa LeCates that she received four requests for the quarterly charitable contributions. Upon a motion by Becky Timmers, seconded by Christine Flores, the recipient of the charitable contribution will be the Kevin Vicary Family Memorial Fund.
- H. <u>IRS Tax Exemption Status</u> Lisa LeCates reported that the tax exempt status request was received by the IRS. As of this date no determination has been made. She reported that we may need to file an extension for our tax return for the year ending June 30, 2008. The initial cost for the auditors is \$600, with subsequent years between \$300 and \$400.

Bylaws Committee – Barbara Altizer reported that the Bylaws have been approved and adopted by both the Southern and Northern Divisions.

Communications Committee – Robin Brock reported that Vicki Varnes will be taking on the responsibilities of editor of the Fire Circle with the Winter Issue.
