AFSS Quarterly Meeting Minutes

December 8, 2009 Hosted by Orange County Fire Authority

A. Call to Order and Introductions:

- President Christine Flores called the meeting to order at 9:10 a.m.
- Warren Johnson, Chaplain, Orange County Fire Authority, provided the inspiration.
- Cathee Harris, Orange County Fire Authority, led the flag salute.
- Fire Chief Keith Richter, Orange County Fire Authority, welcomed everyone to the meeting.
- The attendees gave self-introductions. There were two first-time attendees: Beverly Shapiro (Oceanside), and Beth Springer (City of Orange).

B. Consent Calendar:

Members reviewed the Minutes of the September 15, 2009 meeting and Treasurer's Report.

Motion: Robin Brock (Rancho Cucamonga) moved to approve the Consent Calendar. Paris Profit (Orange County Fire Authority) seconded the motion. Vote: Unanimous.

C. Section Chief's Report:

President Flores reported that Chief Antonucci would not be present and referred everyone to read his article in the current issue of the Fire Circle.

D. Correspondence Report:

Corresponding Secretary Karen McCoy reported that she received a letter from Eric Botkin, thanking AFSS for the charitable contribution.

E. Committee Reports:

Bylaws Committee – Barbara Altizer

Barbara reported that the SOG revisions are being reviewed by the Executive Board.

Communications Committee – Robin Brock

Robin reported that the Winter Edition of the Fire Circle was distributed via email. She asked for feedback from members for recommendations and suggestions on ways the Fire Circle can be improved. The Committee is working on creating a membership database based on specific information including District's vs. Cities, hire dates, etc. The focus of the committee for 2010 is the Cal Chiefs/AFSS website.

Conference Committee – Darilyn O'Dell

Darilyn reported that the 2010 conference has been postponed to 2011. She thanked the committee members who agreed to stay on the committee for an additional year.

Education Committee – Kathy Ford

Kathy reported that they are losing committee members; they started out with five and are down to two. She asked the membership to help look for speakers. The committee currently has a small database of speakers and will work with the host agencies to help them get a speaker if they do not have one in mind.

She then read some of the comments and reasons why Sandy was selected and presented her with the perpetual plaque and engraved silver helmet pendent.

The Executive Board has instituted a new practice of giving the outgoing member of the year a permanent plaque commemorating their award.

G. Educational Program:

Laura Blaul, Assistant Chief/Fire Marshal with the Orange County Fire Authority, presented "Ready! Set! Go! A wildfire action planning program that educates residents on the danger of wildfire and how to properly prepare." At the conclusion of the presentation President Flores presented Chief Blaul with a certificate of appreciation.

H. Committee Meetings

The morning education program and station tour ran long; it was decided not to conduct the Committee Meetings.

I. Old Business:

Christine Flores reported there was no old business to review.

J. Burn Center Testimonial and Acceptance of Toys:

Keri Rodriguez of the Orange County Fire Authority gave a testimonial on the Burn Center. Her young son was burned and despite the odds made a miraculous recovery. The items donated by AFSS members were accepted and will be delivered to the Burn Center by Sylvia Moreno.

K. New Business:

Charitable Contributions

Treasurer Renae Rasmussen announced that the recipient of the \$100 quarterly charitable contribution is Faletusi Liulamaga (nominated by Gracie Ramirez – Oceanside Fire Department.) Mr. Liulamaga is one of fifty employees who are being laid off by the City of Oceanside at the end of December. He is the sole supporter of an extended family. After this unfortunate news, both he a his wife received an unimaginable blow; the tsunami that devastated Samoa in October took the lives of four of his relatives and two of his wife's family members.

Motion: Brenda Best (Orange County Fire Authority) moved to increase the charitable contribution for the quarter to \$250. Carol Tousignant (Morro Bay) seconded the motion. Vote: Unanimous.

Quarterly Meeting Locations

President Flores asked if there were any agencies that would like to host the quarterly meetings in 2010. The following meeting host/locations have been set: March (Anaheim), June (Morro Bay), September (El Segundo), and December (Rancho Cucamonga).

Executive Board Elections

Karen McCoy (City of Riverside) will be installed as the new 2nd Vice President and Vicki Varnes (Chino Valley) as the new Corresponding Secretary.

The survey should take four months to complete.

Beverly Shapiro, Oceanside FD – she thanked everyone for the charitable contribution award to an Oceanside employee. Gracie Ramirez really wanted to be here and thank everyone as well but she was unable to attend.
