• 2007 MEMBER OF THE YEAR:

President Engler presented Kathy Glick with the 2007 Member of the Year award, a silver helmet necklace and our AFSS Division will donate \$200 to a charity of her choice.

VIII. 501 C3 – Treasurer Beville stated that she and Lisa LeCates have applied for separate tax ID numbers, however the 501 C3 status would require approximately \$5,000 in attorney fees, and \$750 per section fee.

Southern section receives larger sponsor donations in comparison to what Northern section receives. If we had status – we could solicit larger sponsorships. It was suggested that we consider sharing attorney fees between Northern and Southern divisions. Proposed estimate is \$2,500 per section plus \$750 filing fee. The Treasurer would be responsible to maintain this status. Shari Holmstrom suggested going with the \$2500 cost – we have the funds and can see future benefits from this status. Motion to spend \$3,250 from our budget – Shari Holmstrom and Linda Hoover/ M/S/C.*

*This motion was then modified to allow for the researching of lower costs. Jodi Martin stated that her department spent about \$1500-\$2000 and suggested we get another estimate. Treasurer Beville asked Jodi Martin to email information so it can be forwarded to Lisa LeCates for consideration. Unanimous vote to move forward.

- IX. Training Officer Symposium The symposium went smoothly thanks to Lynn Pearson and Trudy Maletta. AFSS personnel were utilized in the tracking of payments, signups, telephone, email and fax communication as well as communication with Training Officers. Judy Huss; Christy Cronin assisted with check-in. There was an increase of 100 over last year's attendance totaling 639 attendees. Additional assistance next year from AFSS members would be of great help. President Engler/North will communicate with President Diaz/South to see if any monies have been received to date for our participation.
- X. Legislative Task Force: Treasurer Beville Currently, Dolores Osby represents both North and South, Celia Contreras is the backup representative. Chief Gilbert stated that Cal Chiefs inquired as to whether AFSS would consider handling registration for the June '08 meeting. This task force meeting will be taking place in Sacramento. We need to consider fees we would charge in conjunction with this service. Shari Holmstrom stated we should have AFSS attendees as well as registration workers. Our role should include involvement and participation in the Task Force not just clerical registration support. Sue Beville will add this item to Strategic Planning Meeting agenda as "Legislative Day Teamwork". Strategic Planning Meeting will be held at Mission Inn this year President Engler will be attending.
