#### **Old Business**

- <u>President's Report (added)</u> Valerie E. reported that the transfer of CalChiefs Leadership will be effective Monday, April 14, 2014. Chief Hansen, former President Elect, will become President.
- Academy Debriefing Valerie E. reported the success of the 2014 Academy.
  Thank you to everyone who assisted and made a major contribution. Survey
  results reflect that each attendee found something beneficial to them. Profit of
  \$3,250.00 will be added to the conference account for 2016.
- <u>SOG Update</u> Joyce E. reported the following updates;

pg 17 - Yrs of service, changed to being cumulative per membership

pg 31 – First time attendee scholarship has been renamed Carol Abraham Scholarship.

New SOGs will be sent electronically to the General Membership via e-mail with meeting announcement for the June 2014 meeting.

Wendy C. motioned to adopt, Janice P. second, all adopted by the Board.

- 14/15 Preliminary Budget Joyce E. presented preliminary budget. Requested changes / requests are due to Joyce by May 1, 2014. Budget will be sent electronically to the General Membership via e-mail with meeting announcement for the June 2014 meeting. General Membership will vote to accept 14/15 budget at the June 2014 meeting.
- <u>Financial Audit</u> Valerie E. reminded all that an audit of the previous three years AFSS North financial books needs to be completed ASAP. Wendy C. has a prospective candidate.
- PRP Ad Hoc Committee Valerie E. has requested that we move forward with the revised PRP, Task Book 1. Goals are; draft will be presented to Northern E-Board on Oct. 10<sup>th</sup>. If approved, it will be presented to the joint E-Board on Nov. 4<sup>th</sup>. Final draft will be presented to the General Membership at December 5<sup>th</sup> quarterly meeting. If accepted, will become effective January 1, 2015. Mollie M. and Nancy T. volunteered to be on this committee.

#### **New Business:**

- Meeting Schedule for 14-15 Term Mollie M. created a schedule of all meetings during the 2014-15 term. She will send out schedule to all AFSS North Members via e-mail.
- Committee vacancies Valerie E.
  - Budget The Board would like to take it out of the SOGs. The Treasurer and Board will absorb this responsibility.
  - Education and Training Lara has resigned effective May 1, 2014. Her newest addition to the family is expected very soon. Lara has done a great job and our training sessions are set until 2015. We have to start planning for 2016 Academy.
  - Newsletter We need to have a newsletter. It's an urgent communication tool with our members. We need a new member edition newsletter or information booklet to give to our new members.
  - o <u>Ways and Means</u> We need a plan for fundraising moving forward. Amy Best has not been able to be active. Should we solicit for another volunteer?
- <u>Carol Abraham Scholarship</u> Valerie E.
  - Board would like to be able to send more members to the Annual AFSS Conference / Academy. SOGs will need to be updated to delete the wording of "First Time Attendee." This opens the scholarship up to all members. We will still draw a winner from "First Time Attendee" submittals, in addition to all members who are interested in applying for the scholarship. These scholarships will be funded through the proceeds of the raffle held each year during the December Quarterly General Membership Meeting.

• Community Donation (added) - Valerie E.

The Board has decided that proceeds generated from general membership quarterly meeting raffles (Sept., March and June), will not go into the general budget, but will be earmarked to apply to a community donation. We will solicit general membership for a list of organizations they would like to donate to. The amount of the donation will be dependent on the amount of funds received during the raffles.

• <u>Strategic Plan Ad Hoc Committee</u> – Valerie E.

Need to put together an Ad Hoc Committee to address concerns and recommendations as generated from the February quarterly meeting. Joyce E., Nancy T., Mollie M. volunteered to take part in this committee.

• Review of Bylaws and SOGs - Valerie E.

This will be tasked as part of the Strategic Plan Ad Hoc Committee. Do we need to create guidelines regarding how we handle honoring our AFSS members who pass on? Suggestion; Once a year at Academy, acknowledging them and their contributions to AFSS.

- Website Ad Hoc Committee Valerie E.
  - We will continue to work towards more functionality of the CalChiefs website. Shawn Crawford and Mollie M. have agreed to take part in this committee.
- Membership Project for CalChiefs Valerie E.
   Chief Dutton has requested the assistance of AFSS to take a look at streamlining the membership process for all of CalChiefs. The first meeting will be April 24, 2014. Nancy T., Joyce E., Mollie M. and Jodi M. have volunteered to assist on this project.
- <u>December meeting (Past Presidents' and Members' Meeting)</u> Valerie E. would like to add a formal recognition of Past Presidents and former members as a regular part of each December General Membership Meeting. We will honor our Life Members. Past Presidents will have the opportunity to share with the membership some information about when they served, obstacles and challenges they had while serving. This will be a transitional, historical information piece passed to current members. The Board agreed to this addition.
- <u>Technology needs (added)</u> Valerie E. / Mollie M.
   We are exploring technology resources that will offer members, who are not physically able to attend a meeting, to connect with us electronically. Joint E-board meetings will also benefit from this avenue. Long term goal, online PRP training. Board will add this to the strategic plan.
- <u>Asset inventory</u> Valerie E.
   Joyce E. has been asked to generate a list of our assets. Jodi M. has offered to store AFSS items.

- <u>Pay Pal (added)</u> Valerie E. would like to transfer the PayPal responsibilities to Treasurer, Joyce E., and incorporate a Pay Pal responsibility into our current SOGs under Treasurer.
