

# Quarterly Meeting Minutes September 15, 2009

### **AFSS Quarterly Meeting Minutes**

September 15, 2009 Hosted by Hermosa Beach Fire Department

### A. Call to Order and Introductions:

- President Christine Flores called the meeting to order at 9:14 a.m.

### B. Approval of Minutes:

Members reviewed the Minutes of the June 9, 2009 meeting.

Cal Chiefs worked with California Professional Firefighters on the "Emergency Response Initiative" which would have placed a \$45 charge on all fire insurance policies to fund \$350 million dollars for state and local fire agencies. Unfortunately, this initiative did not make it through the budget process.

### **Host Agency Guidelines and Checklist**
