AFSS QUARTERLY MEETING MINUTES SEPTEMBER 10, 2004 HOSTED BY: BIG BEAR CITY & BIG BEAR LAKE FIRE DEPARTMENTS

A. <u>CALL TO ORDER/INTRODUCTIONS:</u>

- President Nancy Haglund called the meeting to order at 0935 hours.
- Deanne Berry, Big Bear City FD, led the flag salute.
- Corinne Flores, Big Bear Lake FD, provided the inspiration entitled "Be a Queen" written by Oprah Winfrey, from the book *Chicken Soup for the Woman*.
- Ken Hammond, Fire Chief, Big Bear Lake and Dana Van Leuven, Fire Chief, Big Bear City FD, welcomed everyone to the meeting.

5. <u>Member of the Year Nominations – Mary Scott, Chino Valley FPD</u>

Nomination forms were distributed and are available on the website. Forms are due to Mary by November 3, 2004.

I. <u>EDUCATIONAL PROGRAM</u>

Evelyn Beaman, owner of Elevations Day Spa presented the educational program entitled "Adrenal Burn-Out and How to Avoid it." Dr. Charlie was also in attendance and explained the effects stress has on the human body.

J. ROUND TABLE DISCUSSION:

- 1. Christine Flores, Rancho Cucamonga FD-New performance evaluations for Firefighter, Firefighter/Paramedic and Office Specialist have been developed. Each has standards attached to them. The process has taken three years. The Engineer, Captain and ranks above will soon be completed. The department will hire seven new personnel. Recruiting for Deputy Chief. Analyst II position interviews completed.
- 2. Kathy Ford-Borderson, North County FPD-Strategic Plan with reorganization completed. A Deputy Chief and Administrative Captain position were filled, which created two openings in the rank of Captain, Engineer, and Firefighter. These openings were also filled internally.
- 3. Becky Timmers, North County FPD-the department is looking at a possible consolidation of the county's northern area.
- 4. Lisa Le Cates, El Segundo FD-thanked the membership for the \$100 charitable donation to the Nicholas Burns Fund. Nicholas will be undergoing a transplant soon.

- 5. Lenora Viveros, Ventura City FD-The Ventura City FD and the Harbor District will hold a "Fire & Ocean Rescue Day" on October 2, 11am-4pm. Fire Chief Dennis Downs resigned and is now Fire Chief of Pasadena. New Ventura City FD Chief Michael Lavery was appointed in July. The department is currently hiring for various positions.
- 6. Joyce Becker, Ontario FD-New Plan Checker in Fire Prevention section recently hired and a new Firefighter Safety Specialist. The Ontario FD Fire Expo will be held October 2.
- 7. Deanne Berry, Big Bear City FD-The 2005 CA Professional Firefighters' Cookie Calendar will be available in November. Deanne was chosen as one of the cookie recipe winners. Deanne thanked the members for attending today's meeting and suggested that the host location be more centralized to possibly increase the member participation at meetings. Deanne will generate a survey to be fanned out to the members to inquire what are the criteria for members to attend and participate.
- 8. Sue McIlwain, Big Bear Lake FD-actively involved in the possible merger. Captain retiring in October, which will create opening for promotion.
- 9. Corinne Flores, Big Bear Lake FD-Department hired a Fire Fuel Technician, whose responsibility will be to encourage homeowners to create a defensible fuel space. The department will hire one new Firefighter from within.
- 10. Gloria Connors, Chino Valley FPD-department recently hired two new Firefighters. Recruitment is open for Auxiliary Worker; will be recruiting for Accounting Specialist and Administrative Secretary in Personnel. The Fire District has been working on creating a Firefighter Exchange Program with Aguascalientes, Mexico. Firefighters from Aguascalientes will be visiting the Chino Valley Fire District on September 15 through September 20. During their stay, they will participate in tours of the District facilities, training exercises and rideouts. They will also be attending the Firefighter Muster and Chili Cook Off on September 18. The department recently adopted a Resolution to identify stations for the Safe Surrender Program.
- 11. Colleen O'Keefe, West Covina FD-New Chief Richard Elliott. Starting ambulance transport in October. The department has had nine retirees in 10 months. Recently hired three Firefighter/Paramedics leaving six positions open
- 12. Ronda Guillaume, Cathedral City FD-recruiting for Asst. Chief, as the previous one was hired as a Chief in Washington. There are currently six personnel out with injuries. Will be recruiting for FF/PM. Ronda thanked all those who volunteered to serve on committees.
- 13. Carol Tousignant, Morro Bay FD- Captain promoted to Fire Chief in May. Interviews held for Captain's position, with another Captain retiring in one month. City sent out RFP for a new building and hope to begin construction on the apparatus bay by the end of the year. It is unsure at this time, when or if the rest of the station will be built.

14. Nancy Haglund, Arroyo Grande FD-Terry Fibich contracted to Grover Beach as Fire Chief. He is now the Chief for two separate departments. Grover Beach hired six full time staff, while the training officer will be shared between the two cities. Moved into new fire station on July 1. Open house held on July 24. There are four volunteers assisting in the office.

President Nancy Haglund presented Sue McIlwain, Corinne Flores, Big Bear Lake FD, and Deanne Berry, Big Bear City FD, with certificates of appreciation for hosting the September 2004 Quarterly Meeting.

No further business was to be brought before the attendees. The meeting adjourned at 1430 hours.
