President Report

Conference 2012 Update

- Shawn Crawford has resigned as conference chair and position will be co-chair by Jodi and Valerie
- We need to have 50 people registered by December 31st in order to hold conference
 - o You do not need to pay by the 31st but you will need to register
 - The South is encouraging their members to register
 - o If you do register but do not attend you will be billed for the conference

Quarterly Training

- Scannell would like feedback from the membership on the length and content of our training
 - It was proposed that if a trainer was selected whose content would require more than two hours of instructional content, we would consider moving the meeting start time up by an hour to receive the greatest amount of training for our dollar.
 - o General membership agreed to moving the meeting time up to 0900 to have more substantial training, in the event that a trainer requests additional time.
