Lynda and Sallie attended the CalChiefs Strategic Planning Session. The Governor's budget this year included \$25 million for pre-positioning local government fire engines to support the state's critical mutual aid system. So far \$17 million has been spent in 2019. That money may be ongoing, but there is no guarantee for funding every year. CalOES will be auditing six departments each year beginning in 2020 (one per region). Behavioral health and PTSD in first responders was another interesting discussion. Peer support programs are critical resources – last year there were more firefighters lost to suicide than line-of-duty deaths. Sallie enjoyed attending and learning more about how the CalChiefs board operates. She noted a discussion of how technology is used as an effective tool in evacuations and tracking wildfires. The 2020 CalChiefs Conference will be held September 9-11 at the Marriott Santa Clara.
