AFSS Quarterly Meeting Minutes

September 6, 2018 Hosted by Brea Fire Department

A. Call to Order and Introductions

- President Janet Arthur called the meeting to order at 9:11 a.m.
- Christine White, Brea Fire Department led the flag salute.
- Pastor Fernando Villicana, Brea and Fullerton Fire Department offered the inspirational message and discussed leadership and influence. Two different ways of showing leadership is example and inspiration. First level of leadership is positional leadership. It is a starting point. Level two leadership is the next step. They call in sick a little less, etc. and need less direction. A title of position does not indicate what type or how good of a leader you are. Level three leadership is production. Level four leadership is personal development. Level five is pinnacle. It indicates who you are and what you represent. Our willingness to change is vital in becoming a good leader.

We are making more of an effort to go paperless. First Southern Division E-board meeting was on August 17. Discussed lifetime membership voting rights and at the next Joint E-board meeting this will be voted on and an announcement will be made at the December meeting. Discussed Financial Hardship Scholarship. This was approved at August 17 Southern Division E-board meeting. Annette Arenesen is working on badges. Discussed AFSS brochures. These will be in registration packets at the upcoming CalChiefs conference. Janet provided the Annual Report to the CalChiefs for presentation. Updates to SOGs and Bylaws: The board is still working on some minor changes. We are anticipating the SOGs to be completed and sent out by November. Bylaws will take a few more months for voting rights revisions. We still have a vacancy in Treasurer. Membership drive is in full swing. Roster will be posted on our website. New members will be receiving a welcoming packet. As of today, we have about 83 registered members. AFSS requested \$1,500 to CalChiefs to offset some of the money and it was denied.

D. Reports

- Section Chief's Report: Chief Knabe discussed his budget. CalChiefs conference in Sacramento is coming up. Tracey Hansen is the new Executive Director. Succession planning is in place and actively involved in legislature.
- Correspondence Report: Nothing to report
- Committee Report: Education: The December 7th meeting will be in Coronado, we will be having an educational session by one of Liebert, Cassidy and Whitmore's attorneys. They will cover hot and new topics relevant to the fire service and its management. They will touch on what is new and exciting for the fire service in the Firefighters Procedural Bill of Rights (FBOR) and the Federal Labor Standards Act (FLSA). They also will discuss how the FBOR and FLSA play important roles in effective management and supervision and how to avoid perilous pitfalls. We are getting ready for 2019 and the need for educational topics from the members would be greatly appreciated. I would like to say a BIG THANK YOU to Brea, in particular Christine White for stepping up when Chino Valley had to withdraw their hosting of this September meeting. It was great to work with her. Bylaws: The Bylaws have been updated and shared with the northern section for confirmation that both sections are working off the same documents. The changes were in Article 2 - 2.4 adding if a Life Member returns to the fire service, their membership would be suspended, and they would need to become an active member again. **SOGs:** The SOG's were updated in Section Dues and Fees with the new amounts approved by the membership; The Recording Secretary tasks were updated; The Annual Conference Scholarship Programs were updated with a fourth (4th) scholarship, the Life Members Legacy Scholarship. How the scholarships are funded was updated as well for the Life Member Legacy Scholarship. Ways and Means Committee: Audra will be leading this committee. Conference Committee: Conference Committee is working on the upcoming Educational Forum. Keynote speakers are locked in. Most of breakout speakers are on board. Will be working on details to honor Life Members and 30th Anniversary. One of the speakers for Friday Inspirational is Chief Hansen. Michelle is asking members to reach out to Life Members so that we can honor them at the upcoming conference. Conference date is April 30 – May 3 in Paso Robles. A Save the Date is coming out this month. **Membership Committee:** Michelle Pearson is currently working on a smoother process. Ron Liechti joined the committee. Debbie Matthews is working on welcoming packets. Will be getting these out shortly. Packets are for new members only. Discussion on the name badges. - E. <u>Presentation/Educational Program:</u> Overview of the Brea Fire Department & Joint Command Staff Program Chief Knabe, Brea and Fullerton Fire Department; and Chief Loeser, Brea and Fullerton Fire Department

Chief Knabe introduced Battalion Chief Adam Loeser. Chief Knabe showed the membership the San Diego marijuana fire video. Chief Knabe presented the Command Staff Consolidation presentation. In 2011, the two City Managers got together and wanted to save money. A 5-year contract was created for a shared command staff. Philosophy of operations – do what is right, do you best, treat others with respect and be accountable. Discussed how they merged the two departments - community, cost savings, commitment, and culture. Eliminated five command positons, consolidated staff - Fire Chief, 2 Deputy Chiefs, 2 Division Chiefs, 3 Battalion Chiefs and EMS Manager. Consolidated started in May 2011.

Chief Loeser discussed status of the consolidation and the challenges. Brea is similar to Beverly Hills. Fullerton has the characteristics of is an older city. The consolidation has led to more opportunities for different types of incidents. Discussed different cultures and the challenges.

Chief Knabe discussed his challenges. Chief Knabe discussed the JPA. There is still potential to merge. What can we improve upon? Communications and budgeting. Possible future efficiencies include apparatus, fire prevention, clerical, full department merger, and other departments in future.

OES Reimbursement Presentation with Chief Loeser, Brea and Fullerton Fire Department Starts with the CFAA (California Fire Assistance Agreement). A mechanism that allows responding to any fire in CA, the state will reimburse us based on a formula for their assistance. Negotiated reimbursement mechanism for the local government fire agency responses. What to do with the CFAA? Review it yearly in May with your Fire Chief and staff. Update the MOU rates and reimbursable positions. Work through the Administrative Reimbursement Rate formula to determine what it will be for your rate. Default will be 10%, work with your Finance and HR Departments to try to capture a higher percentage.

Do you have a process in place to make your life easier? Discuss with your staff to create the most accurate, effective system.

Communicate with your staff the importance of documentation. Chief Loeser went over their process. It is vital to create a structure to guide the organization for reimbursement packet and make sure your BC has it and understands it. Chief Loeser went over Brea and Fullerton's Strike Team/Single Resource Checklist.

Who is the initial gatekeeper of the paperwork? More than likely the on-duty Battalion Chief. They should be able to verify that all of the correct forms are completed and attached to the packet to be submitted for eventual reimbursement.

Once the crews submit their Strike Team paperwork to BC, another Chief Officer should take one last look at it before submitting it.

Establish those relationships locally within the County and within the State for assistance. Once you completed the reimbursement packet, verify everything. Next, a file will be created and wait for an invoice from OES. Realize that once you receive the completed packet, your attention to detail and follow through is paramount to finalizing this transaction. Let Finance know you submitted for mutual aid reimbursement from the State. Should take about 3-6 months for reimbursement. Make a copy of the check and file it with your packet.
